Join us as we travel to Washington, D.C. in April 2025. (You may even get to see the cherry blossoms in bloom!) It's our goal to have an even larger and stronger delegation attend on April 29 & 30. You can go to the IAMIC website and apply for a

scholarship. Applications are due by March 3, 2025. This is your opportunity to be present and discuss the pressing issues of the Mutual Industry with your Congressmen and women.

You are invited to our Illinois Advocacy monthly calls. All Mutual members are encouraged to participate in these monthly Government Relations (GR) advocacy calls. During these sessions, you will join our lobbyist, Evan Manning, along with members of our GR committee, who can provide insight into any concerns. These discussions aim to generate topics and information that contribute to a more substantial legislative process. Please refer to the schedule of calls on Page 1.

Did you know that if you have 10 or more employees, you are required to follow the Secure 2 Act for Retirement...ARE YOU IN COMPLIANCE?

The new law requires that you offer retirement savings options for employees (even part-time if they have worked over 500 hours in a three-year time frame). Companies are not required to contribute, but they must have an option available for their employees.

Beginning in 2025, this law requires employees to automatically enroll in the plan at a 3% contribution rate. Employees who do not wish to make this contribution must opt-out, and employers should keep a signed document. IAMIC offers a multiemployer 401K plan that offers discounted costs and ensures compliance with the IRS documentation.


